Introduction

In December 2020, RDA Tasmania hosted a webinar for Tasmanians interested in learning more about the Building Better Regions Fund Round Five. Following a question from an attendee, RDA Tasmania offered to provide a register of consultants who provide services to support applicants.

- Applicants sometimes use consultants to support them to write sections of the applications they need help with.
- Applicants report that they use consultants only when necessary and the cost of engaging them represents good value for money.
- They also report that it helps to be very clear about what outcome is intended by engaging the consultant and specific about the output they want so it is the best possible help for their application.

The consultants register is free to be listed in and any consultant wishing to be listed needs to simply contact Kevin Turner (kevin.turner@rdatasmania.org.au) to organise it. This is the first time RDA Tasmania has tried to compile a register of consultants and in the likelihood that many consultants have been unintentionally missed off, we welcome to hear from more consultants and anyone who can recommend one.
